Subject:- Extension of Special Package of Industrial Incentives for the State of Himachal Pradesh and Uttarakhand.

The undersigned is directed to refer this department OM of even number dated 4<sup>th</sup> March, 2014 vide which Notification of the Scheme on the above mentioned subject were circulated and Directorate of Industries, Uttarakhand letter No.676/Dol(V)-CCIS/2014-15 dated 27<sup>th</sup> May 2014 and Directorate of Industries, Himachal Pradesh letter No. Ind. Dev. (Special Package-II)/2013-14 dated 19<sup>th</sup> May, 2014 on the above mentioned subject vide which both the State Government have requested to amend para 6 of the Notification of the Scheme by extending the time period for registration under the scheme in respect of units which have commenced commercial production after 7<sup>th</sup> January, 2013 but not registered with the DIC concerned during the intervening period or have not submitted claim within one year of date of commencement of commercial production/operation.

2. The request has been examined and it has been decided to extend the relaxation for registration of such units and submission of claims to DIC upto 31<sup>st</sup> of August, 2014 under the extended Package.
